

Developed primarily through an extensive survey of the NAIC member states, the Insurance Department Resources Report (IDRR) is organized into five sections: Staffing; Budget and Funding; Examination and Oversight; Insurance Producers; and Consumer Services and Antifraud.

An overview of the 2008 IDRR report findings include:

- Premiums increased by 3.5 percent to \$1.6 trillion from 2007 to 2008.
- In 2008, the five states with the most premiums written in all lines were California, New York, Florida, Texas and Pennsylvania. These five states accounted for 40.4 percent of all insurance premiums in the United States.
- There were 7,948 domestic U.S. insurers in 2008.
- State insurance departments received more than 337,000 official complaints and 2.2 million inquiries.
