

Beginning with the 2010 report, the NAIC will be releasing the IDRR in two volumes. The first volume will include substantially all of the information we normally include in the annual Report except for premium volume data. The second volume will primarily encompass the premium information not available at the time of publishing the earlier volume.

Developed primarily through an extensive survey of the NAIC member states, the IDRR – Volume One is organized into five sections: Staffing; Budget and Funding; Examination and Oversight; Insurance Producers; and Consumer Services and Antifraud.

An overview of the 2010 IDRR – Volume One report findings include:

- California reported the largest 2012 budget, which is \$25.9 million greater than the second-largest 2012 budget (New York).
- Total taxes collected increased by \$510.4 million from 2009.
- There were 7,863 domestic U.S. insurers in 2009.
- State insurance departments received more than 304,000 official complaints and 2.1 million inquiries.
